RESEARCH INTERESTS

My research has primarily focused on the study of poverty perception, particularly through attributions about poverty, and the support people show for social protection policies aimed at improving the situation of those in poverty. To do this, I have employed both correlational and experimental designs in the studies and projects I have conducted. In these studies, I have also utilized various statistical analysis techniques, such as multilevel analysis, path analysis, structural equation modeling, and CFA (Confirmatory Factor Analysis) or latent profile analysis.

I have conducted research on socioeconomic status and its operationalization, perceptions of justice and satisfaction with democracy, dehumanization towards refugee groups, and punitive attitudes towards the unemployed. In some of these studies, I have collaborated with international research teams. All of my research endeavors aim to rigorously adhere to open science practices, as can be observed in the studies in which I have been involved, especially those that I have led. I have shared both materials and R code used, as well as preregistered studies whenever possible.

I am interested in placing my research within a broader context by drawing on other fields such as history, social philosophy, sociology, or political sciences. Additionally, on a more informal note, I have an interest in the philosophy of science.
